*PLEASE NOTE:* <u>All displays must be completely set up by 9:00am on Saturday, September 26</u>. Vendors shall only sell foods approved. Selling un-authorized food items may result in vendor not being allowed back at future events. Vendors must post prices of all food / products in large letters so that it may be read from 10' away. Failure to do so will result in permanent banning from future events. *YOU CAN NOT PARK AT YOUR BOOTH.* A Florida Food License will be required by the State. The State of Florida Health Inspector may choose to inspect vendor's tents and trailers. Be prepared that there may be a charge by the inspector if your area is not up to code and you do not have the proper licenses. Cooking, heating and cooling equipment, must meet State Fire Department Standards.</u>
